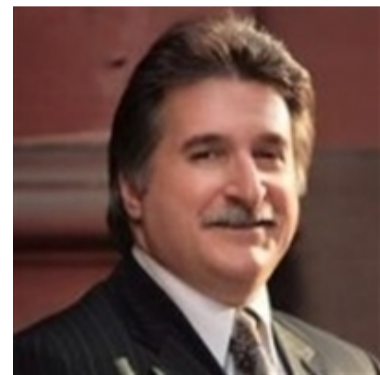
Will challenges occur frequently in Britain
